The wells for Lincoln Rural Water have received a moderate and lower ranking in terms of susceptibility to contamination,

Lincoln Rural Water Association routinely monitors for as many as 154 constituents in you drinking water according to Federal and State laws. This table shows the results of our monitoring for the period of January 1st to December 31st, 2023 All drinking water, including bottled drinking water, may be reasonably expected to contain at least a small amount of some constituents. It's important to remember that the presence of these constituents does not necessarily pose a health risk.

In this table you will find many terms and abbreviations you might not be familiar with. To help you better understand these Terms we've provided the following definitions:

Action Level - The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Maximum Contaminant Level - The "Maximum Allowed" (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal - The "Goal (MCLG) is the level of a contaminant in drinking water below which there is no know or expected risk to health. MCLG'S allow for a margin of safety.

Addition information for Lead

If present elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing.
